10- Executive Director - HNB: Nic Jansen

Report As submitted. Nic presented a summary of his report highlighting the main points from this past season.

11- UNB Sport Law Clinic - Kelly VanBuskirk

Nic introduced Kelly VanBuskirk who presented to the group virtually. Kelly touched on the following:

- Started a new Sport Law Clinic last fall. It's a credit course in which students get credit for participation. Each Student has a background in sports and the clinic focused this year on HNB.
- The students did a comprehensive review of the HNB Constitution and created a template to help associations create or update their Constitutions.
- There were quite a few investigations (complaints) which Kelly supervised.
- The investigations and reports by the students were well done.
- The service provided to HNB met or exceeded expectations.
- The UNB Sports Law Clinic has reached interest from National and Provincial Sport organizations.
- For the 2024-2025 season, the clinic is looking to increase the volume of investigations and continue to work with Nic and HNB.
- Some associations were reluctant to participate in the investigations. Kelly asked everyone to speak with their associations. The UNB Law school is working on behalf of HNB, and the investigations are serious and should work with the UNB Sports Law students. The clinic is beneficial to everyone. Every complaint should be investigated and addressed for quick resolution and correction. Participation is crucial.

- U9 Program
- U7 Program
- Female AA, A, B

15.2 A competitive team shall be composed of a minimum of 12 players, excluding affiliate/associate players, 1 of whom must be a full-time goaltender, except U13 and below. A 'C' and a female AA, A or B team shall be composed of a minimum of 8 rostered players, excluding affiliate/associate players, 1 of whom must be a full-time goaltender, except U13 and below.

15.5 The following definitions shall apply:

- a. Division: U7, U9, U11, U13, U15, U18, and U21.
- b. Category: AAA, AA, A, B and C.
- c. Classification: Development, Competitive, and C.
- d. Checking hockey includes U15 division and above AAA, AA, A, and B categories.

Non-checking hockey includes U11, U13 and 'C' classification.

e. For female hockey:

Division: U7, U9, U11, U13, U15, U18

Category: Female AAA, Female AA, Female B

Classification: Development, Competitive and Female

All female hockey is non-checking.

15.10 Goalkeepers

- a. Player Roster Forms upon which goalkeepers are registered shall be clearly marked as goalkeeper, except U13 and below.
- b. No replacement can be made for an ill or injured player, except the goaltender. (Refer to HNB Regulation 106.g).
- c. For "C", Female AA, Female A and Female B teams, a replacement for an absent goaltender may come from the same category, in the division or lower division, provided permission is obtained from the District Director and the goaltender's team. For Female, permission may be obtained from the Female Commissioner or Female Representative to Minor Council

U11 - team classification

For the initial registration of teams, the number of players registered by a Minor Hockey Association within a division will be used as follows:

AA – for every 60 players, the association must have an AA team

- Discretion is provided + / 10
- Associations will not have more than 3 'AA' teams.

A - 24-59 players

- Discretion is provided + / 10
- The above numbers represent the requirement to have A and AA teams.
- Additional teams are at the discretion of the association.
- a. U11 AA teams can be formed between neighboring associations who do not meet the minimum number of players with the approval of the Board of Directors from each association as well as the District Director.
- b. Minor Hockey Associations can make a request to their District Director at the start of the season to play at the highest level without meeting the required numbers.
- Minor Associations may register more than one team in the same classification within a division. These teams must be balanced.
- d. If a player's home association does not offer U11 AA, the player can transfer to a neighboring association. If they do not make the AA team, they must return to their home association.
- e. It's recommended that associations have no less than 50% of their teams at the recreational level.

The motion to amend section 15.13 and to break it out to subsections was approved.

The first subsection was voted on and was defeated.

U11 - team classification

For the initial registration of teams, the number of players registered by a Minor Hockey Association within a division will be used as follows:

AA – for every 60 players, the association must have an AA team

- Discretion is provided + / 10
- Associations will not have more than 3 'AA' teams.

Once defeated, the mover Luc Martin withdrew this amendment in its entirety.

Travel teams may be permitted by the Female Commission on a case by case basis where circumstances warrant, Considerations may include but are not limited to location/geography of the players, travel distances and ice restrictions. The movement of players from their age-appropriate division will only be permitted with the approval of the District Director.

For upward player movement to competitive division:

Registered non-AAA co-ed teams shall adhere to the following criteria with respect to the use of underage players in any division of minor hockey:

a. The upward player movement shall be available for second year players beginning in U9 including exceptional players with the movement to Competitive C or above with approval of District Director. Players in their second year of a division are eligible to be evaluated for player movement. It shall be at the discretion of the Minor Hockey Association and District Director to move players from U9 to U11 (competitive or recreational divisions). For player movement from U11 to U13, U13 to U15 and U15 to U18, players must rank in the top third of the highest category team in the next division or club.

For player movement related to AAA, please refer to the EHC Exceptional Player Status Guidelines.

- b. Overall hockey ability.
- c. Physical development.
- d. Social development.
- e. The Selection Committee must be independent of the coaching staff of the team and must be made up of a representative of both the NBMHC and NBEHC, or their representatives.
- f. All players (aged and under-aged) must be evaluated objectively and ranked by the Selection Committee.
- g. The District Director from whose area the under-aged player is coming, must approve the selection and file same immediately with the Executive Director.
- h. The use of the player must remain consistent with this ranking during the playing season or his status may be revisited by the District Director responsible for his league.
- i. To balance program requirements of the association/club.

j. A fee of \$250.00, payable to the Hockey New Brunswick District.

k. All requests for upward player movement must be received one week prior to the Association try-outs starting, or at the discretion of the District Director.

For upward player movement to recreational division

Players must roster within their appropriate age division unless permission is granted by their District Director for a second year 'C' player to move up one division within the 'C' level. The District Director shall use the "Risk, Safety and Conduct Management" criteria for determining such movement.

For downward player movement (female players playing co-ed):

At the discretion of the district director, female co-ed players may be permitted to play down one division and play at the co-ed "C" level. Each request is reviewed on a case-by-case basis and the District Director shall use the following criteria for determining such movement: a. Risk and safety management. b. Medical. c. Compassion d. Development of the player.

First year Female players may play down one division in a co-ed competitive division if they reside in a district that does not have a female competitive team.

For downward player movement (male players):

At the discretion of the District Director, male players may be permitted to play down one division and play at the co-ed "C" level. Each request is reviewed on a case-by-case basis and the District Director shall use the following criteria for determining such movement: a. Risk and safety management. b. Medical. c. Compassion d. Development of the player.

The player must be evaluated to be in the bottom 50% of players on the lower category team that the player is to be rostered to. Once the overage player is approved on the roster they are permitted to participate in provincial playoffs.

The movement of female players from their age-appropriate female division will only be permitted with the approval of the Female Minor Council representative.

For downward player movement:

At the discretion of the Female Minor Council representative, female players may be permitted to play down one division and play at the Female A level. Each request is reviewed on a case-by-case basis and the Female Minor Council representative shall use the following criteria for determining such movement: a. Risk and safety management. b. Medical. c. Compassion d. Development of the player.

For upward player movement to competitive division:

Registered non-AAA female teams shall adhere to the following criteria with respect to the use of underage players in any division of minor hockey:

- a. The upward player movement shall be available for second year players beginning in U9 including exceptional players with the movement to Competitive A or above with approval of Female Minor Council Representative. Players in their second year of a division are eligible to be evaluated for player movement to the highest category team in the next division of that Association or club. Note: For player movement related to AAA, please refer to the EHC Exceptional Player Status Guidelines.
- b. Overall hockey ability.
- c. Physical development.
- d. Social development

- e. Players must rank in the top third of their position of the upper level team (skill level). In the U11 division only, players must rank in the top third of all skaters. Goaltenders must rank as the top goalie in the evaluation.
- f. The Selection Committee must be independent of the coaching staff of the team and must be made up of a representative of both the NBFC and NBEHC, or their representatives.
- g. All players (aged and under-aged) must be evaluated objectively and ranked by the Selection Committee.
- h. The District Director from whose area the under-aged player is coming, must approve the selection and file same immediately with the Executive Director.
- i. The use of the player must remain consistent with this ranking during the playing season or the player's status may be revisited by the Female Minor Council representative.
- j. To balance program requirements of the association/club.
- k. A fee of \$250.00, payable to the Hockey New Brunswick District.
- I. All requests for upward player movement must be received one week prior to the Association try-outs starting, or at the discretion of the ROC Female Hockey Representative.

Female players may dual register with a Minor co-ed and female team only if approval is provided by the ROC Female Hockey and the Minor Female Representatives. Proposed wording:

A team played a game with 1 or more ineligible players or Team Official.

When a game is declared forfeited due to a team playing with 1 or more ineligible players / Team Official the non-offending team shall be declared the winner and score shall be recorded as per the Official Game Report if the non-offending team was in the lead at the time of the infraction or as 5-0 if the non-offending team was not in the lead. The players on both teams shall be credited with all personal statistics earned up to the time the forfeit was declared. Should the game in question be part of a tournament, the offending team shall automatically be relegated to the final position in the tournament standings. The use of an ineligible player / Team Official shall be reported to the Branch Executive Director.

13- Hockey Canada Registry 3.0 - Josh Bell

Nic introduced Josh Bell from Hockey Canada who presented to the group virtually. Josh touched on the following:

- Overview of the HCR 3.0 and benefits.
- New Features being rolled out Tournaments, HC Special Programming, Events, Single Sign-On with the Learning Lab and Registration, Rostering and Waitlist Improvements.
- Third Party Issues which lead to increased administration time, increased cost and incorrect reporting. Registration and rostering directly with the HCR will solve these issues.
- Hockey Canada Data Hub which will be added into the HCR and the MHA's will be able to view their Organization reports. Some of the reports that will be available will be the Registration Report, Transaction Report, Clinics/Stores Report, Invoice Report, etc.

14- U11 Provincials - Luc Martin

HNB received a request for U11 Provincials to be included next season. The format would be 8 teams in AA, A and B, and 16 teams in C. This request is being brought to the floor to see if associations are interested in adding U11 to the Provincials. Luc facilitated a vote to include the U11 Provincials for the 2024-2025 season. Carried

U15B - Non-Checking League - Luc Martin

Minor Council have had discussion on whether U15 B should change to a non-checking division. It was decided to add this to the Minor AGM agenda and have the Minor Hockey Associations vote on whether U15 B changes to a non-checking division. Luc facilitated a vote to include a U15 B Non-checking division. Carried

15- Minor Chair Election - Nic Jansen

The nomination package for the HNB Minor Council Chair was distributed on March 14th. The deadline to submit nominations was May 9th. Luc Martin is the only nomination received; therefore, he'll be re-elected for a two-year term by acclamation.

16- Outgoing Minor Council Members - Luc Martin

Luc thanked Kris Dupuis (District 7 Director) who is the only outgoing member for his hard work and dedication throughout the last few years and presented him with a plaque and gift.

MINOR HOCKEY PRESIDENT'S REPORT - Luc Martin

Another season has just been completed, and once again minor hockey, female hockey, development hockey and the officials' association have continued to collaborate and work together to develop and improve our programs, although with some of our partners the approach is more difficult than others. This past season, HNB offered several development camps and certifications.

The following courses were offered online:

-Coach 1: 461 -Coach 2: 570 -Safety: 374

-Respect - Leader: 1054 - 17 recert -Respect - Parent: 1385 - 23 recert

- -94 people took Development 1 training; one course was given online and 4 others on site in Fredericton, Saint John, Bathurst and Moncton
- -4 goalie clinics were held online: 2 in English and 2 in French. The following associations provided ice time for on-site training: 2 FYHA, 2 Saint John, Acadian Peninsula, Bathurst and Grand Falls. I'd like to thank Matt Vautour for organizing these clinics.

The only negative point is that the training is almost all online now and HNB, along with the district directors, will still have to chase down the associations to get their members to take the mandatory training before the deadline.

I attended more than 61 meetings this season for different reasons. The Minor Hockey Board (HNB) meets regularly to discuss the advancement of our sport. For the past few seasons, HNB has held 3 online meetings with the province's minor hockey associations; the participation rate is quite good, but all associations should have someone present at these meetings. During these meetings, HNB shares very good and important information, which is very useful for the associations and helps them manage their current season.

PROVINCIALS

This season, the Minor Council and HNB decided to hold provincial championships in all levels of the U11 division.

The provincial championships were held over 2 weekends this season: March 21 to 23, for the U11, U13 and U15, AA and B divisions, and March 28 to 30, for the U11, U13 and U15, and U18 AA, A, C divisions.

I'd like to thank the hosts for organizing and coordinating these provincial tournaments and congratulate the champion and runner-up teams.

16 provincial tournaments were held for a total of 145 teams that participated in these tournaments, and during these two provincial tournament weekends, I had the chance to visit 10 different locations. During my visits, what impressed me the most was that the tournament organizing committee was very well organized and had many volunteers who participated. If it weren't for the volunteers, the tournaments wouldn't happen. I had the chance to talk to a lot of coaches, parents and volunteers. What's always impressive on these weekends is to see the positive energy of so many volunteers who get involved to make these tournaments a success. I'd like to thank all the volunteers - without your dedication, there wouldn't be a provincial tournament in our province.

There have been no major incidents at any of these tournaments, apart from a few suspensions. We must always improve and work to have the best teams at these tournaments. I've noted a few areas where the minor council should be looking at improving.

SUSPENSION

This year was a busy one for suspensions, with a total of 565 suspensions, 477 players and 88 coaches, compared with 518 suspensions, 437 players and 81 coaches in the 2023-2024 season. During the season we had to carry out 35 Hearing with suspended players or coaches, the Minor Council Disciplinary Committee had to meet very often to render decisions on suspensions and video reviews.

The majority of suspensions are at the U18 C level, and the Minor Council will have to work to find a solution to reduce suspensions at this level. Some infractions do not change from season to season, we received a total of 15 infractions under section 11.5 Physical abuse of an official and 57 infractions under article 7.10 B, for fighting. This is far too many, and we need to work with officials and associations to try and reduce physical abuse towards them. No official, no game. With social media, you need (association) to have a more vigilant control what your teams put on social media, it goes around the province pretty fast.

The HNB Minor Council, have implemented in the minimum disciplinary standards in section 8, when a team that receives seven (7) different match penalties, fighting majors or maltreatment suspensions will have to attend a hearing with representatives from the minor hockey association, district and Hockey New Brunswick Minor Council. This season we had to meet with 5 teams, one of which was suspended in March for the remainder of the season. This is the last resort the Minor Council wants to take. The associations have a job to do with their problem teams before they reach the maximum number of suspensions.

COMMENTS

I repeat myself every year, in my reports from previous years, there is still inappropriate behavior in the arenas during minor hockey games. This season I witnessed a few incidents where coaches, parents and grandparents were involved in the stands. When we see grandparents and parents to yell at young officials at U9 and U11 level, there's a problem. These young officials must start somewhere. One incident is one incident too many.

People believe that hockey is a right, not a privilege. This must continue to be a national priority. As a result, HNB has taken several steps to change behavior. We introduced the Parent Code of conduct policy to HNB participants, and HNB introduced mandatory "Respect in Sport" training for parents.

As you can see, the Minor Council takes certain suspensions very seriously. We're aware that some suspensions are part of hockey and happen in the heat of the moment. But in the case of unnecessary suspensions, such as those for fighting and maltreatment, or when coaches are ejected from a game and the other coaches on the bench refuse to submit the name of the offending coach, the minor council will investigate the offences and issue more severe sanctions. A grand total of 88 coaches were suspended this season, so it's time for associations to become more vigilant in their choice of coach.

The work between minor hockey and the AOHNB/NBHOA officials' association is improving, but there's still a lot of work to be done together. One of the things we get a lot of complaints about is post-game reports (scoresheets). Many scoresheets are of poor quality, penalties are not indicated, scoresheets are not signed by officials, and on a few occasions this season, suspensions were not issued because officials were more than 48 hours late in submitting their reports.

The lack of training available, and the lack of evaluation or follow-up after training in some regions seem significant. In all the discussions, judging and work were never called into question, but rather the support surrounding young officials. We're aware that there's a shortage of officials everywhere, but better support might enable us to recruit more and retain some. The service offered must remain standard from one region to another, and between the different groups, whether in minor hockey, development hockey, high school or other calibers. We feel that minor hockey is not getting the priority it should.

Demographics remain a challenge for the smaller centers. However, the larger centers are much more open-minded and willing to work with the smaller centers.

In some divisions, we may have to look at and follow the model of the U18 Central league. This league has been working very well for several years now.

In Conclusion, my minor council and I still have challenges ahead of us that we must overcome. However, we always continue to work together to improve minor hockey in the province, and to ensure that all young people have a place to play hockey. I'd like to thank Nic Jansen for all the help he's given me over the years. Nic Jansen is a very important part of the HNB Minor Council. Thank you to Michelle Currie, who is always available to help on the minor council and answer many calls during the hockey season. Thanks to the HNB staff (Heather, Matt, Brogan and Katie) for all their hard work. In closing, I'd like to thank all my HNB minor council for the support they've given me and for their excellent work in their region, as well as all the volunteers who are involved in their association, for the good development of hockey in New Brunswick.

Here is my report for the 2024-2025 season. District 1 is represented by 4 active community clubs. To make a comparison with last year, the associations have seen an increase in their registration, which is good, and the U7 and U9 level have seen a big increase which bodes well for next year. As for the referees, the number to remain the same.

At the beginning of the season, I met with the managers of the U7 to U18 teams to explain them how the district works and the rules of the different categories. We're going to do this again next year and even do one with the coaches of each category. We also met with the presidents of the district 2 associations, and we will do the same exercise at the beginning of the season.

During the season, we had a total of 8 meetings with a good number of participants, a lot of effort was put again this year by the associations to ensure that all their volunteers have the necessary courses to be compliant before the deadline. We must work with our associations and coaches to ensure that fair play is respected. It's a good challenge because the level of competitiveness of the coaches is very present.

At the provincial championship levels District 1 was well represented in the various provincials and came back with 3 banners and the district had 9 teams that participated, congratulations to all the teams.

My goals for next year are obviously to implement electronic score sheets and the establishment of a Zone A league for all competitive and recreational teams with District 2 and 3. In closing, I would like to thank the members of the district executive (Marc-André, Marc and Cindy), the presidents of the associations (Éric, Patrice and Philippe, Pascal, Joey), ROC Éric Lebel, referee-inchief Jacques Lebel, women's hockey Arianne Milliard, the president of the minor council Luc Martin as well as all the volunteers for their involvement and all the efforts put into ensuring the smooth running of hockey in our region.

DISTRICT 8 REPORT – Ian Donald

District 8 teams experienced a year of moderate success. The four associations within District 8 had teams participating in the Northshore Minor Hockey League (NSMHL) and attended at all age levels of provincials. Although no provincial banners were brought back to the area this season, the regular season play was competitive and successful, with signs of stable health in participant numbers at the U7/U9 age levels.

The play structure in Zone D needs improvement. The NSMHL is making commendable efforts to establish a Zone league, which works well for competitive divisions. However, District 9 does not participate at the C level, making it difficult to determine provincial attendees each year. Modernizing the league to include all Zone teams would be beneficial, providing clarity on provincial participants. With some creativity, the League could extend the season with a Championship weekend or playoffs. It is also suggested that all minor leagues should be Zone leagues, potentially operated by HNB for consistent operations and rules.

The caliber of teams from Zone D is a serious concern, especially with the number of teams within the EDZA model. Zone D should consider pausing its involvement with EDZA. Stronger players could join AA/A level teams in their local associations, improving their competitiveness at the provincial level. Elite players will always find their way to elite teams. Currently, if a player is "pretty good" and their parents can afford it, they can play at the EDZA level, which is unfortunate.

Hockey seems to have become a niche sport, no longer the main passion for many participants. Access to other sports, activities, and social interests has led to a decline in the quality of play. Many players attend games but show less interest in practice. We need to be realistic with our expectations and support the participants according to their needs and skill levels.

The behavior in arenas is concerning. Aggressive and reactive behavior has become common in many New Brunswick arenas. Hockey NB's efforts are commendable but not progressing quickly enough. I fully support a Zero-Tolerance policy for inappropriate behavior during HNB-sanctioned events, including suspending players if their parent, grandparent, or caregiver is involved in misconduct. This would quickly address obscenities, foul language, and inappropriate behaviors. Responsibility for curbing these behaviors lies with HNB, individuals, teams, and associations.

Lastly, my participation on the Minor Council Discipline Committee is rewarding and provides great insight into some issues facing our sport. It does however require considerable time and effort but validates my concerns about behavior during HNB-sanctioned events. Additional focus on adjusting disciplinary standards and penalizing repeat offenders will help keep players safe and engaged in the sport.

It is a pleasure to represent District 8 and Minor Council, and I look forward to a summer break before we resume in the fall.

The Peninsula has grown to 751 registrations in 2024-2025, an increase of almost 50 registrations. The 131 girls represent 17% of registrations and their number has increased by 2% compared to last season.

From U11 upwards, most players are "double carded" to enable them to play a few games in an all-female team.

We made Tier 1 and Tier 2 teams at U9 level. On the whole, this division worked better than last year. The teams were better divided.

The number of goalies is always a problem. The possibility of affiliating goalies with several teams helps, but is not enough.

Volunteers are always slow to obtain their criminal record checks before the deadline. Suspensions are on the rise, especially at U18C level. Complaints are also on the rise. In summary, the 2024-2025 season was an eventful one. Many difficult decisions had to be made.

For the coming season, Daniel Roussel and I have agreed to make presentations to the teams about the operations manual and rules or disciplinary standards and more. We realize that most don't take the time to consult these documents.

Congratulations to all the teams who took part in the provincial championships, and especially to the Gladiatrices U11A Tier 3 for winning gold. Congratulations to the Lamèque/Shippagan and Tracadie committees for organizing the U13AA and U13C championships. Both championships were a great success.

In closing, I'd like to thank my vice-president Gaétanne Beaudin Roussel, who so kindly stood in for me for a few weeks during my mourning period. She supervised the Provincial U13AA with great care.

Thanks to the HNB staff for their help and to Luc Martin for his ongoing support. EXECUTIVE DIRECTOR REPORT - Nic Jansen

As we celebrate another season for Hockey New Brunswick, I'd like to provide an overview of initiatives and programs from the 2024-2025 season:

The 2024 National Women's Under-18 Championship was held November 3rd- 9th in Quispamsis. In conjunction with the event, several development initiatives were held, including Esso Fun Day skills camps, a We are Coaches certification clinic, a coaching seminar, and an officiating clinic.

In April, Hockey Canada announced that the 2026 Esso Cup will be held in Dieppe, New Brunswick. Hockey New Brunswick will work with Hockey Canada and the local organizing committee to run Development initiatives in conjunction with the event.

Hockey New Brunswick has partnered with the University of New Brunswick law program. As part of our collaboration with the UNB Sport Law Clinic, students are engaged as independent third-party investigators to conduct investigations into complaints, ensuring impartiality and professionalism in the process. On February 21st, the UNB Sport Law Clinic hosted a symposium featuring presentations on a range of important topics, including: liability in sport; combatting politics in youth sports; anti-doping laws; structuring a safe sport conflict resolution program; transgender athletes in women's sports; the impact of NCAA rule changes on Canadian university hockey; and Hockey New Brunswick's efforts to address maltreatment in the sport.

Hockey New Brunswick ran Neurodiverse camps in Dieppe, Quispamsis, and Fredericton. The program was free of charge and open to all neurodiverse youth between the ages of 5 to 17, a total of 75 participants took part in the sessions that included 10 on-ice sessions. For the first time, a Jamboree was held in Dieppe that included participants from all three programs. The Jamboree included games, a pizza party and wrapped up with the Moncton Wildcats game.

This season, Hockey New Brunswick hosted seven Equity, Diversity, and Inclusion workshops with over 200 participants attending. The participants included players, coaches, officials, parents, and volunteers. The focus of the workshops was making our sport more inclusive, how we can accommodate the differences of people and ideas to promote diversity awareness.

Congratulations to the SEFHA Fury Female U13 AAA, SEFHA Fury Female U15 AAA, Dieppe Flyers U15 AAA, Moncton Flyers U18 AAA and Edmundston Blizzard Jr A on winning Regional Championships this season.

Thanks again to all the outstanding volunteers throughout New Brunswick. It's a pleasure to work with a passionate and dedicated group of volunteers.
